CHURCH MATCHING SCHOLARSHIP PROGRAM

The King's College is proud to partner with churches and ministries in developing the next generation of Christian leaders. King's will match contributions from a church or ministry for their King's student, up to \$1,500 per year.

Student Eligibility Requirements:

- Be accepted for admission to The King's College for the fall of 2021
- Be enrolling full-time in a degree-seeking program
- Maintain academic good standing

Scholarship Limitations:

- Matching awards are subject to the availability of funds. Matched funds from King's may only be applied toward tuition expenses.
- The Church/Ministry may not send funds from wages, internships, or gifts from individuals to a specific student for the Church Matching Scholarship
- King's will only match a check from a single Church/Ministry.

How To Apply:

1. Send the application to your Church/Ministry.
2. Have your Church/Ministry mail the check, along with the completed application to:

3. Contributions must be made via check by the Church/Ministry directly .
4. Checks should be payable to The King's College. Write the student's name and "Church Match" on the memo line.
5. Submit checks by August 1st for the Fall Semester, and December 1st for the Spring.
Note: A student's parents, relatives, or friends may not make a gift to the Church and request the funds be sent to the student.
